President's Annual Report for Lutheran Church of the Resurrection 2020

Looking back on the last three years on council and the last two being president, I am happy we have been able to move forward on many aspects of our ministry. We continue to thoughtfully engage the work and guidance provided by Kairos and Vernon Research Group congregational surveys even as we continue to evaluate our present needs and circumstances. We have embraced a general norm of operations that allows our staff to make day-to-day decisions while the council concentrates on a more strategic role. We are grateful to have knowledgeable staff to support the ministry of the congregation.

This year we said goodbye to interim pastor Denny Wright and welcomed Pastor Jeff Frohner and his lovely wife, Kelly, to our church family. We retained interim associate pastor Nate Montover with a shared agreement with Hope Lutheran Church. The Jeff-and-Nate team is well received by the congregation.

Our mission continues to be to "WELCOME people to a community of faith; CONNECT people to Jesus through the Word of God; and SEND disciples into the world to SERVE in Jesus's name." We continued to focus on these objectives in 2020 with the three council sub-teams: Outreach, Stewardship, and Governance.

The Outreach Team has been working on making our church accessible and welcoming for new and future members. Additionally, we were successful in transitioning Cari Redondo into the director of communications position which has been more than an awesome fit. Recognizing some of the worship challenges that surfaced this year, we have retooled our video equipment to live stream services. The website has been refreshed and we are now rolling out Sign-up Genius to assist in volunteer coordination and communication. All these activities focus on welcoming and connecting the congregation and increasing our digital footprint to attract new LCR church members.

The Stewardship Team, along with the staff, has done a fabulous job in keeping expenses under control and our church financially solid. The Paycheck Protection Program loan from the government allowed us to continue to meet salary commitments for staff that could work during the pandemic. The team has pulled back where possible without losing sight of our Mission's goals. They have done an excellent job of navigating a tough year financially. We are grateful for all the people of LCR who have faithfully supported our ministry this past year. Through your generosity you are not only living out your role as disciples; but allow us to continue to be the church. Through the leadership of Bob Erlandson, we have re-instated the Property Team with the goal of not just looking at what needs to be fixed today but planning for expenses in the next four to five years. The work being done here relates to that more strategic outlook on running the church, as well as enabling us to send people to serve in the community.

The Governance Team under Dave Gochenouer's leadership has done a phenomenal job in updating the constitution and by-laws to reflect how the church has been running over the past several years. These updates fall in line with the restructuring of the Council to teams and the empowerment of the staff to accomplish the day-to-day activities. These documents have been converted to electronic records from marked up hard copies and addendums which was no small task. Dave worked with Joan Meyer to update the Trust documentation to improve transparency in legacy giving. This work cements our mission in providing structure around welcoming, connecting, sending, and serving.

Serving on Council has been hectic and unusual this year. Yet it is rewarding to see progress toward our goals in part due to the exceptional caliber of talent in the staff, council, and pastor positions.

SENIOR PASTOR'S REPORT

Pastor's Annual Report to the Congregation

"This is my command—be strong and courageous! Do not be afraid or discouraged. For the Lord your God is with you wherever you go." Joshua 1.9 NLT

As I've begun my time with you here at Lutheran Church of the Resurrection the above scripture from Joshua has served as a constant beacon before me. These words were given to Joshua by the Lord in a time of great transition: Moses had died, the people where in the Wilderness, and the journey forward into the Promised Land was about to begin.

I believe these words from God to Joshua are words that God is speaking to us as well. Like the ancient Hebrew people we find ourselves in the midst of transition, uncertainty and a call to move forward. We are called to let go of any discouragement and fear in favor of being confident that God is with us. This promise must be at the heart of our life together as we move into the future that God is preparing.

Strong: We have many strengths here at LCR. I have been impressed by the many people who love their Lord and church. There is a strong sense of community at LCR that longs to live out the Gospel. We have staff members who bring passion and joy to their service in our midst (By the way, be sure to thank them often and purposely). We are also fortunate to have Pastor Nate Montover serving part time as one of your pastors. He not only brings competence to the office, but does so with great humility and grace. I am grateful for him and his ministry at LCR and Hope Lutheran. We have been nurtured by godly women and men upon whose shoulders we stand and enjoy the blessings that they have helped bring about. There is a love for learning and a yearning to be engaged in scripture and connecting our everyday lives to the faith we confess.

Arguably one of the greatest strengths we have is a deep concern for neighbor that is manifest in a long history of LCR being a force for good in Marion and beyond: Marion Cares, Take Away Hunger, Feeding Lunch to Youth (FLY), Lutheran World Relief, Reverse Advent Boxes, Christmas Adopt-a-Family, Blood Drive, EWALU, Jail Ministry, Camp Chisomo, Churches of Marion Food Bank and much more.

Courageous: Over the years LCR has shown itself able to attentively listen to the leading of the Holy Spirit and navigate the challenges before us. During this past year, in the midst of many obstacles (Pandemic, Derecho, Pastoral transition, political strife, difficult social justice conversations) LCR has kept itself engaged in the community, embraced new technology and found ways to lift up the Gospel even when the path of resignation would have proven easier to follow. It takes courage to adapt and face head-on multiple adversities and LCR has shown this type of courage throughout its history as a congregation. **Do not be afraid or discouraged**: While we should not take counsel of our fears, we would do well to name them and to be realistic about the challenges through which God will help us navigate. We have several challenges that we need to be aware.

<u>Decline in stakeholders and resources</u>: Over the past two years we have seen some 70 people/family units become inactive in their participation/support or formally disengage from LCR altogether. This in turn

represents an approximate \$100,000 decline in ministry resources. This coming year (2021) because of your faithful stewardship and the good efforts of the LCR Staff/Leaders we have nearly \$70,000 in cash surplus. This allows us to enter into the year fully funding our current mission and ministry—including a Biblical tithe of 10% to benevolence/good work beyond the congregation. Thanks be to God. It does find us short in regards to calling a full time Associate pastor and our ability to fund all of the desired upgrades to the campus. That being said, I am very grateful as without this cash surplus we would find ourselves approximately \$70,000 short of meeting our current operational expenses and basic ministry priorities. We need to move forward in confidence of God's continued presence; nevertheless we need to be aware of the realities that would ensue if we are unable to change this trend. Let's tackle this challenge together! Healing of wounds and maintaining a healthy congregation: In our worship we have what is called the

"Kyrie." It means simply, Lord have mercy. There are wounds in the life of any congregation that need to be healed with the life-giving power of Jesus Christ. Pastors, leaders, staff, congregational members are all at various times subject to and participate in moments where our mutual brokenness is on display. Unfortunately such brokenness can lead to lack of trust and behavior that tears down the body of Christ instead of building us up as the Apostle Paul enjoined (Let all things be done for building up, *1 Cor. 14.26*; As each part is working properly, promotes the body's growth in building itself up in love, *Ephesians 4.16*). While we can't deny some of the hurtful moments in our past, even here at LCR; we cannot allow them to define our future. With the promise of God's presence in our midst we must all work at being "ambassadors for Christ" and cultivate the fruits of the Spirit (By contrast, the fruit of the Spirit is love, joy, peace, patience, kindness, generosity, faithfulness, gentleness, and self-control. There is no law against such things. *Galatians 5.22-23*.)

For the Lord your God is with you: I am delighted to be here as one of your pastors and I am confident in the promise that the Lord is with us! I am confident that the Holy Spirit was at work in the Call process, even if it was somewhat unusual! I appreciate your patience with me as I'm still very much a new face in your midst and still learning about LCR and the community. Please keep introducing yourself and don't hesitate to reach out to me. I understand how hard and frustrating it can be during this Covid-19 pandemic ; but I am confident that we will soon –please Lord—begin to enter into more normal days. And even if 2021 is

another year of uncertainty and upheaval; the promise of God, shown to us in the love of Jesus Christ is that upon which we stand. It is on the promise of Jesus that we find our strength and resilience. And it is on Christ the solid rock that we remain unmoved—not naïve to the realities of our world, nevertheless confident in God's continued guidance. To Christ Jesus be all glory and praise, in the unity of the Father and the Holy Spirit.

LCR Stewardship Team addressed several major issues this past year. At the start the team made final arrangements to the 2020 budget for the annual meeting and continued work to finalize details in the financial package for the call of our new Senior Pastor. Since spring the team addressed financial challenges of the Covid-19 pandemic and later the Derecho damage. In the late summer and fall the work was focused on the 2021 Fund Appeal and preparation of a consolidated single-fund LCR budget for 2021. More budget details are found in the annual report financial section.

On the side, the team helped with Trust Fund related aspects (detailed in an August Cross Talk article) and arrangements for a planned giving seminar. The seminar was originally scheduled for April but moved to a virtual meeting (via Zoom) in September because of pandemic constraints. Since it was well-received by a small group, further sessions may be offered in 2021.

The 2021 Fund Appeal material packet was developed by a small task group of Stewardship Team members, staff, and congregation volunteers (the Fall Appeal task group) with the help of Pr. Frohner. The Fall Appeal task team worked quickly and efficiently to generate a smaller packet set for this year that included a cover letter, an information brochure, and a commitment form. The appeal with the theme "Giving - Sharing - Serving," was discussed in a temple talk for both online services October 18 and in 3 weekly sermons in November.

Because of the pandemic, arrangements were made to distribute the Fall Appeal material electronically, if indicated by congregation members, or by postal mail. Since over 100 families opted for electronic (e-mail) delivery, some LCR packet printing and mailing costs were saved. The Appeal results are summarized below. In 2020 we started with a small operating cash surplus and were able to end the year with a larger surplus thanks to the faithful giving of our members, funding opportunities provided during the pandemic, and the reduction in expenses due to the partial-year shutdown. That surplus is proposed to help fund the larger operating expenses expected in 2021 as well as some needed facility upgrades and the start of a reserve fund for unexpected facility maintenance items. More details are contained in the annual report "green pages." Many thanks are due to the Stewardship Team and the Fund Appeal task group members listed below.

LCR Property Advisory and Planning (PAP) Team 2020 Year-End Report

The LCR congregation council approved formation in September 2020 of a new team for dealing with church building and property maintenance and upgrade issues. The team consists of one or two council members, the LCR office manager, and a few congregation members.

One of the first issues the team has assessed is LCR's electricity usage. We learned that twice in 2019 LCR's peak power demand exceeded the limit prescribed by our rate category. After receiving results from a walk-through with a Linn County REC commercial energy advisor, the team decided to begin a needed upgrade this fall of 1/3 of the LCR florescent light fixtures. Ballasts were removed in about 85 fixtures and the fixtures converted to use more efficient, longer lifetime, ballast-bypass LED tubes. The effort this fall focused on the Gathering Space, Main Office and office corridor with special attention to 6 fixtures that run continuously for security. Each LED-converted fixture draws less than half the power and should have more than twice the lifetime compared to the original florescent tube fixtures. An REC rebate helped partially offset the conversion cost in 2020. Many thanks to all the volunteers who helped with that project. The next step is to convert the remaining florescent fixtures (about 250) to LED tubes in 2021.

A second project addressed by a volunteer task group was re-carpeting, painting, repairing doors and replacing window blinds in the Fellowship Hall. This work was necessary in part because of the previously-planned effort to repair the concrete floor, but also the August Derecho damage. The whole Fellowship Hall effort should be completed in January 2021 and make a noticeable improvement. Thanks to all the task group, led by Nyla Vanourny, for their hard work and dedication.

A third major effort was development of a facility upgrade plan with cost estimates as an input to the Stewardship Team for the overall LCR 2021 budget. Due mostly to cost constraints, two items of that plan were eventually chosen for incorporation in the budget: (1) completion of the florescent light fixture conversion to LED tubes, and (2) adding outdoor security cameras to our building's security system. Other items from the plan are expected to be carried over to 2022 and beyond.

In addition, the team has monitored the Derecho damage repair effort. Damage to the Fellowship Hall wall

(interior), kitchen gable end, garage roof, and entryway wooden windscreens have been repaired. Other repairs will be undertaken early in 2021. A more complete description and status update will be given at the annual meeting. Many thanks go out to the great group of volunteers who helped with the Fall Clean-up Day activity and to the other PAP Team members for their work this past fall.

An advantage of the electronic options is that we can import giving data into each LCR participant's giving record thus reducing the processing time and any chance for error. Currently 29% of our givers use one of the electronic options.

Approximately 52% of LCR families returned the fall stewardship appeal commitment pledges. <u>This data is</u> <u>valuable in LCR's budgeting process</u>. It is one component of LCR income, but has proven to be a very reliable indication of total income. We encourage all members to return their pledge forms.

If you give electronically and don't receive envelopes but would like to give toward special offering opportunities there are envelopes available in the rack by the Welcome Center. You may also give special offerings electronically via the LCR website. Just click on "use this donation for" and select an option.

Audit Committee: (Jon Lovseth, Pam Brown, Andy Johnson); December 29, 2020 (reporting on 2019) **1. General Fund, Clearing and Growth & Outreach Accounts**. Evelyn Beck provided documents for the February and June test months. The committee compared the checks written and checks cleared to the check documentation, account activity register, bank statement, and Council Summary. Also, the December Council report was compared to the bank reconciliation. Four minor disbursement differences were noted. The deposits were traced to the bank statement. There were weekly deposits as expected. The average Sunday deposits for February and June were \$14,601 and \$14,270, respectively. No deposit exceptions noted.

2. Quilters. Harriet Van Gilder provided documents for the audit. The checkbook balance matched the Annual Report and bank reconciliation at the end of the year. Deposits and distributions were reasonable amounts for items that fit the ministry purpose. Receipts were present for distributions. No exceptions noted.

3. ELCW Circle. Harriet Van Gilder provided documents for audit. The checkbook balance matched the Annual Report and bank reconciliation. Deposits and distributions were reasonable amounts for items that fit the ministry purpose. Deposit amounts matched offering recorded from LCR. Receipts were present for distributions. No exceptions noted.

4. Trust Fund. Treasurer, Joan Meyer, provided the Trust Fund statements, checking account statement, and checkbook ledger. The ending balances trust fund investments listed in the trust 2019 treasurer's report were compared to the checking statement, ELCA Mission Investment Fund CDs and ELCA Endowment Fund. All checks were for scholarships and matched designated recipients and amounts. Mission Investment Fund interest was entirely deposited and accounted for in the checking account. Records indicate all income in the endowment fund was reinvested.

The 2019 Trust Fund ending balance was \$174,469.15. This is \$2,883 more than the 2019 annual report due to the Annual Report using balance from November 30, 2019 for the ELCA pooled Trust Fund instead of the year end statement.

5. General Internal controls. The Treasurer and Office Manager positions were combined in 2012. The office manager does everything: writes and signs checks, maintains the general ledger, and reconciles the bank account. No one pre-approves the invoices before payment.

Recommend establishing a committee to include the Office Manager to review the LCR's accounting system procedures and compare to best practices. There may be ways to institute checks and balances to strengthen the internal control system. A strong internal control system protects both LCR's and the Office Manager's interests.

Fellowship Highlights in 2020:

- Virtual Coffee When we first shifted to online worship in the spring, Mary Jo & Roger Carlson started a Zoom gathering prior to worship each Sunday morning so people could share their highs, lows, and everything in between. Then when we switched to Drive-In Worship in the summer, Mary Jo & Roger moved the gatherings off the computer screen and into the parking lot.
- Wednesday Zoom Fellowship Evening Song Worship attenders on Wednesdays were early adopters of Zoom last spring. They added a fellowship time prior to worship so Wednesday night friends could catch up from week to week.
- **Members Outreach** Our Care Ministers have maintained a 'visits ministry' to our homebound and care center members for several years, but in 2020 we stepped up our game with calls, cards, and mailings to members who had no access to our online resources. *If you know of anyone who could use friendly call once in a while, please let us know in the church office.*
- Water Bottle Ministry LCR usually opens our doors to Butterfield Park visitors each summer for bathroom breaks and water bottle refills, but due to Covid this year we had to keep them locked out. It didn't feel one bit right, so instead we provided them with a 'Little Free Water Pantry,' built by Marlin Oeltjen and stocked by donations from caring Resurrection members and friends.
- **Drive-thru Farewell for Pastor Denny** (9/23/20) We got to bid farewell to our interim senior pastor Denny Wright and his wife Winnie on a lovely fall evening.
- **Coffee With the Pastor** (Sep & Oct 2020) Folks were able to get acquainted with our new senior pastor Jeff Frohner in a series of small group visits this fall.
- **LCR Happy Halloween** event (10/28/20) Our youth programming staff pulled out all the stops for the kids this Halloween with a drive-thru event where they could play games, get CANDY, and immortalize their awesome costumes at the photo booth.
- **Christmas CARE-oling Food Drive-thru** (12/19/20) Matthew Lang and his band of merry singers set up under the canopy one afternoon to sing as listeners drove through with donations for the Marion Food Pantry.
- **Christmas Eve Outdoor Gatherings** (12/24/20) We decided to expand our Christmas options this year with two afternoon get-togethers for families. It was a little chilly but we got the fire pits roaring, sang carols, warmed up with cocoa, and shared the beloved story of our savior's birth.

Many of our standing fellowship groups had to suspend in 2020, but we are looking forward to resuming our gatherings as soon as we can!



LCR participated in many Social Concern projects despite the restrictions of COVID-19. LCR volunteers gave from their hearts to help those in need by donating their time and money to support a wide range of causes in 2020. Thank you to everyone who volunteered their time and money to all of these worthy causes. God Bless.

Highlights from the past year include:



LCR members helped with a record year of FLY (Feeding Lunches to Youth). Approximately, 60 LCR adults and youth helped to make 23,402 lunches this summer for FLY. This is 3 times the number served in past years. FLY was extended by 3 weeks due to the Derecho and kept going even when the power was out. LCR members generously donated financially to FLY. It cost about \$34,000 to run this year's program so donations were greatly needed for this difficult year in our community.

LCR funded four meals for Mission of Hope this year.



The Churches of Marion Food Pantry was supported in many ways by several LCR volunteers such as stocking shelves, helping to distribute food and picking up supplies. In addition, LCR members helped to start a no contact delivery service for several families that were unable to come to the pantry in person. A combined Food Pantry and FLY driveup food drive brought in much needed items for both organizations in May.

LCR members adopted 7 families from the MISD Holiday Giving Project and provided gifts for struggling area families. In addition to fully supporting the 7 families, LCR was also able to help additional families due to the generosity of our members. Gift cards to Walmart and Hy-Vee were purchased to help an additional 6 families that had not been fully supported. A special thanks to the LCR quilters who donated 7 beautiful quilts to the families LCR adopted.

Continued support for our Mission Partners through our Mission envelope giving. Partners receiving funds from our envelopes this year include: FLY, Matthew 25, Community Free Health Clinic, Churches of Marion Food Pantry, ELCA World Hunger and the Catherine McAuley Center.

The Marion Cares Backpack Program and the Start Schools Right Shoe Drive were also supported by LCR. Through backpack/supply purchases and monetary donations LCR was able to provide 36 backpacks to children in need in the Linn Mar and Marion Districts. 17 pairs of new shoes were donated and \$325 was raised to purchase shoes for students.

the area, the church building sustained considerable damage. Volunteers again stepped up to clear away debris and do repair work to the church. A lot of painting was done, and replacing damaged items is ongoing. Thanks you so much to everyone who stepped up to help.

Your children were creative and caring in the ways they engaged with hardships, something I will not forget as we continue to serve the kingdom together.

Sunday School went from in-person meetings, to drive-by deliveries and emailed coloring sheets over the summer. Oh what a year this has been for Wednesday Night Live. Life changed in March when we went to all online programing. The last thing WNL did as a large group was the annual Lenten meal. Thanks to all the volunteers and parents who helped make it possible. Unfortunately, we didn't get to do our annual shopping trip for the Food Pantry. We hope and pray that we may be able to get that in sometime in 2021.

In the months following Lent, the kids and I learned how to navigate Zoom and even managed to have games and lessons online. We have become masters at screen sharing and Pictionary. (The kids are exceedingly good guessers.) WNL went clear into June as we just needed the time together to talk and laugh. Some of the WNL kids even took up my flower challenge and raised their own plants.

In the fall, our group changed to a 4th – 6th grade program to align with changes in our confirmation program. We have been meeting online via Zoom for much of the year. Early in the fall we were able to meet in small groups of 10 and alternated nights on which students came to church. After the in-person groups met, we did a Zoom check-in with the students who didn't meet at the church. In November, WNL moved back to online-only meetings after the surge in COVID numbers. We plan to go back to meeting in small groups again in January.

We did manage to have some fun and do service work along the way in our mixed-up year. 2020 was a tremendous year of learning in regard to communications in the church! In early 2020, we were refreshing brochures, reaching out through social media, working on our website, putting together hand-outs and posters for Bible studies and Lent activities. We were making hospitality-focused improvements, advertising LifeTree Café and our upcoming Easter services.

In mid-March, our focus turned to online services. The first Sunday that we offered worship exclusively online, we taped our out-of-date IPhone to a music stand and had Pastor Denny speak to the congregation via Facebook Live. By that Wednesday, we were able to broadcast a livestream service. With everyone's encouragement and support, we have evolved from those first services to services produced by our pastors and musicians in their homes, to parking lot AM-broadcast services, to parking lot livestream services, to the installation of a wonderful suite of audio and visual technology that allows us to provide a high-quality streamed service that is distributed simultaneously to both Facebook and YouTube. Thank you so much for your prayers as the church worked hard to bring worship to you.

While we were already making improvements to our website, those enhancements accelerated as we rapidly expanded online content. The number of pages on our website more than doubled during 2020, and users accessed our website nearly 19,000 times, for a total of almost 34,000 pageviews. We provided more than 200 videos on YouTube, which together had around 25,000 views and nearly 4000 hours of viewing time, and we added over 200 subscribers to our channel. We also added a significant number of subscribers/followers on social media. During Advent, we provided daily devotions through a printed booklet, our website, three social media platforms, YouTube messages and via text message.

In addition to providing digital content, we also learned a lot about interactive digital technology. The official new verb of 2020 was ZOOM. We used Zoom to host Sunday morning "coffee" fellowship, Wednesday Evening Song worship, gather for Bible studies, meet our new pastor, and do the work of the church in meetings.

Through all of this, we were motivated to connect our church family and reach out to our community; to share the message of God's love through His son, Jesus Christ, who served as the ultimate "Communicator" by stretching His arms across the divide of our sin, and enabling us to have a relationship with our Creator. INTRODUCTION TO 2021 BUDGET

I. Review of 2020

Since we've combined our two funds for 2021 the figures below represent the combined funds

- Our original receipts estimate was \$679,800 a 15% decrease from 2020 totals
- 2020 receipts were \$727,712 or 107% of our target of \$679,800
- 2020 expenses were 658,793 or 97% of our 2020 budget of 680,343
- We began the year with \$70,853 in the combined funds and ended the year with \$140,032.
- Most years we receive an average of 98% of pledges as income and we base future receipts projections on that pattern. In 2020 we received 97.8% of pledges as income, compared to 95.7% in 2019.
- Takeaway Receipts were higher this year because members continued to give through the pandemic closures and we were able to take advantage of some funding opportunities offered during the pandemic. Expenses were lower due to the closures so we were able to come out of the year with a surplus.

IV. Summary - General Fund proposed income of \$680,000.

Specifics on the Proposed 2021 Budget

Mission Partners – We estimate that \$68,000 will be given to our global and mission partners from our combined budget income. Our estimated total giving is \$680,000. **The total projected mission partner giving of \$68,000 would be 10.0% - a tithe of total giving.** We will increase our giving to the ELCA from \$30,000 to \$33,000. We have designated benevolence \$18,900 to go to our local mission partners: \$3,000 to Camp EWALU; \$5,500 to host a Take Away Hunger event; \$3,000 to Habitat for Humanity; Camp Chisomo Scholarships \$5,000; Fresh Start Jail Ministries \$1,000; Mission of Hope meals \$1,200. We have designated \$16,100 in other benevolence. These funds will only be spent if estimated income is received. Our Mission envelopes will be the same as last year: FLY, Matthew 25, Community Free Health Clinic, Churches of Marion Food Pantry, ELCA World Hunger, and the Catherine McAuley Center.

Pastoral Compensation – Pastoral compensation for Pastor Frohner remains as per letter of call. Compensation for Pastor Montover remains as contracted for part-time associate.

Lay Staff Compensation – A 1.5% cost of living adjustment (COLA) has been applied to all lay staff.

Budget Deficit: Our 2021 budget reflects a deficit of \$67,810. In 2020 we were able to come through the year with a budget surplus due to the faithful giving of our members, funding opportunities provided during the pandemic, and the reduction in expenses due to the partial year shutdown. These factors led to a cash surplus as of the end of 2020. Therefore, our 2021 budget assumes that we will use that surplus cash created in 2020 to cover the additional expenses in 2021 that are over the income expected in 2021. These additional funds will allow us to add some facility projects to our annual budget including starting to create a reserve for the future, as well as returning our LCR benevolence giving to a tithe.
